PSHE ASSOCIATION FIREWORK SAFETY LESSON PACK

These resources have been around for a few years now, but given that it is that time of year, we thought it was worth a quick reminder! These two lessons from the PSHE Association will help schools with KS2 & 3 students raise awareness of firework related risks and injuries and help students to reflect on how they can positively influence the actions and behaviour of their peers.

The resource pack includes interactives slides and full teacher guidance for each lesson, which cover:

- A KS2 session that focuses on assessing and managing risks around fireworks, bonfires and sparklers
- A KS3 session that explores personal safety, managing risk around fireworks and bonfires, and the law regarding the use of fireworks

And yes, these ones are for members only, but then again if you aren't a member of the PSHE Association – why not?!! **You can find these resources here**, and then log in to your account download.


RSHE: IMPLEMENTATION OF THE 2020 CURRICULUM GUIDANCE IN SCHOOL REPORT

Published at the end of September, a new DfE report called 'Relationships, sex and health education Implementation of the 2020 curriculum guidance in school' (that really rolls of the tongue, doesn't it?!) is based on research that was commissioned by the previous government to look at how the RSHE guidance has been going down in schools.

The report presents findings from research conducted on behalf of the DfE, which explored how the guidance has been implemented in schools, as well as how closely the implementation of the guidance has lined up with the Department's Theory of Change (i.e. how closely it worked based on the DfE's own expectations of its implementation).

The research consisted of a quantitative survey with 2,510 school staff and followup qualitative case studies with 14 of the schools that took part in the survey. In total, 1,039 school leaders (headteachers, assistant headteachers and deputy headteachers), 953 RSHE coordinators, and 518 teachers took part from a range of settings.

As you might expect of a paper of this nature, it is quite a meaty read (128 pages in total!) but it has some really interesting sections on things like school approaches to delivering the guidance, use of external providers, pupil and parental engagement work, and CPD for teachers and teacher confidence. Given that we had the backdrop of the consultation on the draft update to the RSHE guidance hit a few months ago, although it's quite a read it is worth at least a cursory look if any of the sections included are areas you want to focus on back in school. But if you've already got a good book on the go, then I wouldn't put it down especially for this!! You can access the paper here.



FREE FINANCIAL EDUCATION TRAINING

Young Money (part of Young Enterprise) are providing free CPD certified financial education training sessions for a wide range of educators working in the primary, secondary and SEND sectors.

GIRLGUIDING GIRLS' ATTITUDES SURVEY 2024

YOUNG

Now in its 16th year, the Girls' Attitudes survey from Girlguiding has run annually since 2009 and the 2024 edition has recently been published. It surveyed over 2,500 girls and young women as a sample of girls across the UK to ask how they feel about their everyday lives and what it means to be a girl today.

The results this year show that the pressures and challenges of being a girl in 2024 are felt more intensely and at a younger age. Girls as young as 7 feel they have to look and behave in a certain way and the pressure gets worse as girls get older. It sadly also highlights and reminds us about the concerning levels of inequality and misogyny facing girls and young women. Some key findings include:





- 59% of 13 to 21-year-olds have seen or experienced sexual harassment
- 47% of 11 to 21-year-olds feel less safe because of sexism and misogyny, a significant rise from 17% 10 years ago
- 81% of girls and young women aged 11 to 21 said boys think girls should look like images they see online
- Over I in 5 girls aged 7 to 10 have seen rude images online. This has doubled since 2021
- More than half of girls (55%) aged 7 to 21 have received negative comments about their appearance

If you've not yet tapped into any of the Girls' Attitudes surveys, we would urge you to take a look as the representative sample provides useful reminders and focus on the work that we all need to do in school, either via PSHE or on whole school pieces and behaviour, to support positive outcomes for our students.

NSPCC LEARNING PODCAST ON RSE

NSPCC Learning has recently published a podcast episode on relationships and sex education and the NSPCC's Talk Relationships service which supports secondary schools to confidently deliver inclusive RSE.



In the episode, actor and Childline ambassador Natalie Dormer is joined by two secondary school teachers to talk about what it's like to teach sex and relationships education. They discuss the challenges teachers face as well as practical solutions to these problems. Points covered include the importance of focusing on equality, diversity and inclusion; the impact of social media on the way young people learn about sex and relationships; and taking a whole school approach to delivering RSE.

Training and Development opportunities

Our popular professional development training sessions run throughout the academic year, with courses offered across a range of themes related to PSHE education. These training sessions are open to all, regardless of whether your school is signed up to a service support package with us or not. **Course places start from just £59 or come at no additional charge for school's that buy into one of our service level agreements.** Please try one of our sessions if you need some decent CPD!

For certain courses, we also offer delegates an additional bespoke one-to-one follow up session with a specialist PSHE advisor. As well as attendance at the training session, delegates who book this option (\pounds 99) will be able to access an individual one hour online follow up meeting to help discuss any specific issues for their school around the themes in the training session – ideal for those schools who need that extra bit of help or reassurance that they are putting the right things in place.





We also offer Inset or 'twilight' training opportunities to enable schools to effectively deliver key learning points to wider groups of staff, either virtually or in school. We work with a wide range of specialists so can always develop bespoke sessions on PSHErelated themes if schools have additional or combined topics they would like to address.

A variety of introductory Governor-specific training sessions are also available, aimed at raising awareness around health and wellbeing themes, such as RSE, Health Education, Anti-Bullying, School Food, Substances and Mental Health and Emotional Wellbeing. These can be delivered both virtually and in school and at different times of the day to make them as accessible as possible to Governors.
